Clubhouse Day Trip—Sauder’s Museum

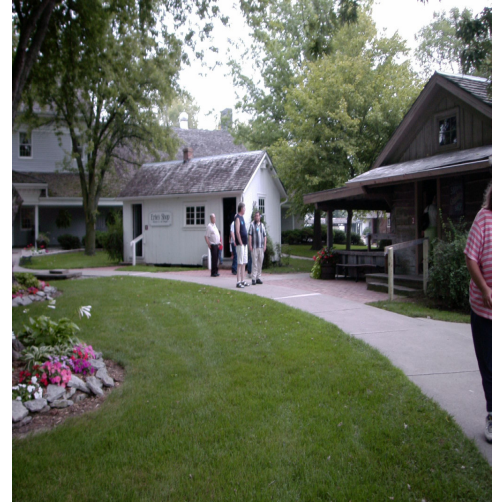

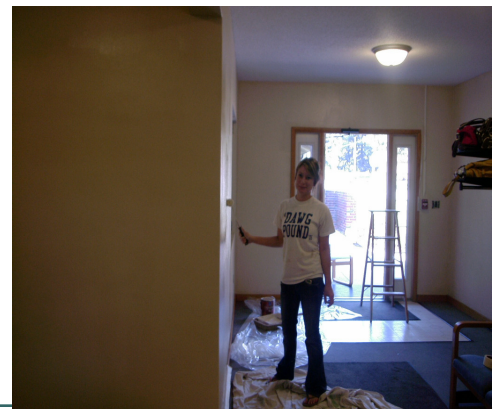
