Dual Diagnosis

The Dual Diagnosis Group is for clients at any stage in the change process. We strive to meet the client where they are in their journey of motivation to change.

This is a group for clients that may recognize that they have a problem, but are not ready to commit to lifelong sobriety. Resistant clients that deny they have a problem can also benefit from this group. Clients will find the support they need to do well.

Clients must agree to maintain sobriety for the 20 week program, take random drug screens, and participate in all weekly sessions.

Our Master's level clinician is highly trained in mental health and substance use disorders. The goal is to educate the client so they can understand and process their own substance use and mental health issues and assist them on their road to recovery.

Topics Covered

- Mental and physiological effects of alcohol and drugs.
- Mental illness and its impact on addiction.
- Analyze the individual's reasons for use and abuse.
- Analyze the consequences of use for each individual.
- Provide support for change & recovery.
- Develop coping skills for each individual's triggers.
- Develop a personalized plan for recovery including their mental illness.
- Information on alcohol, stimulants, opiates, inhalants, marijuana, PCP, hallucinogens, ecstasy, and methamphetamine.
- Assignments to practice and process throughout the 20 weeks.



BENEFITS

- Licensed Professional Clinical Counselor facilitates the group.
- Treatment for both mental health and AOD issues can take place during each group meeting.
- Monthly reports are sent for individuals who have a legal obligation to attend.
- No waiting time- group members can join at any point in the group.
- Aftercare options are available for those who may need continued help after completion of the program.
- Our team approach allows them access to a psychiatrist and case management if needed.
