SSVF Services

Maumee Valley Guidance Center can provide the following services to those who qualify:

Assistance to obtaining Veteran Administration benefits.

Referrals for services including:

- Health Care Services
- Childcare Services
- Legal Services
- Credit Counseling
- Housing Counseling

Temporary Financial Assistance, including time limited payments to third parties for:

- Rent
- Utilities
- Moving expenses
- Security/utility deposits
- Transportation
- Emergency supplies

Participant Eligibility

This program serves veterans in: Defiance, Fulton, Henry, Williams and Paulding Counties.

1. Veteran Family

Family (with dependent children) in which the head of the household or the spouse of the head of the household is a veteran or a single veteran.

(Surviving spouses are ineligible for assistance.)

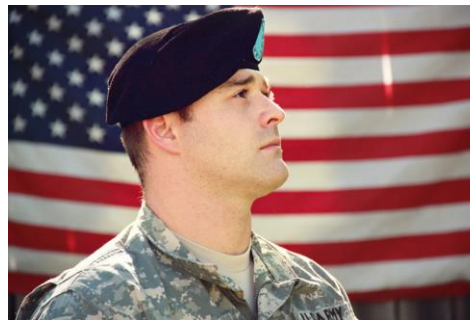
2. Very Low Income

Below 50% of area median income.

(Call for income criteria)

3. Current Housing Situation

Homeless or At-Risk of being Homeless.

Your Veteran Status

To qualify for supportive services under the SSVF program, you must be a “Veteran” is defined as a person who has served in any branch of the Armed Forces of the United States regardless of the length of service. This includes those who were discharged or released while attending training but discharged before reporting to a duty station.
